**pSivida Limited (pSivida) - Notice Under Section 708A of the Corporations Act 2001 (Cth) (Act)**

As previously announced to the Australian Securities Exchange (**ASX**), following the conversion of certain unlisted convertible notes, pSivida has issued an aggregate of 1,234,570 fully paid ordinary shares (**Shares**), issued as 123,457 American Depositary Shares on 17 April 2007.
